Required Documentation to Accompany W-7 Form The IRS requires specific identification documents to verify your foreign status and your identity. The main document required is a valid Passport. Passport - the only document you can submit alone/without any other of the documents

Required Documentation - Itin w7 Application

What documentation is required for the ITIN application? If you plan to submit copies of ITIN documents, you need to make sure they are certified copies. Certified copies are provided directly from the issuing agency that made your original document. The issuing agency will provide a stamped certification seal proving that the copy is accurate.

How do I apply for an ITIN? Use the latest revision of Form W-7, Application for IRS Individual Taxpayer Identification Number to apply. Attach a valid federal income tax return, unless you qualify for an exception, and include your original proof of identity or copies certified by issuing agency and foreign status documents.

These documents will be accepted. A notarized document is one that the taxpayer provides to a public notary who bears witness to the signing of the official document and affixes a seal assuring that the document is legitimate. These documents will not be accepted for ITIN applications. Note there are some applicants who are exempt from this change.

If you will need your documents for any purpose within 60 days of submitting your ITIN application, you may wish to apply in person at an IRS Taxpayer Assistance Center or a CAA. See Where To Apply, later. 3. The documentation you provide must be current (that is, not expired).

If a passport is not being submitted along with the application, then at least two supporting documents must be submitted with the application. Supporting documents must also be submitted for dependents if the passport doesn't include a date of entry into the U.S. Any document submitted must meet these requirements:

Verify that all information is accurate and matches your supporting documentation. Complete the W-7 form through the Online Application. Include your original federal tax return (s) for which the ITIN is required. Attach the W-7 PDF we send to you via e-mail, to the front of your tax return

Step by Step Instructions - Itin w7 Application

When you apply for an ITIN, you'll usually submit several kinds of supporting documentation along with your Internal Revenue Service W-7 form. Many people prefer to submit original passports or certified copies, as it satisfies both requirements to prove one's identity and foreign status. However, the IRS accepts original versions or certified copies of other important documents that satisfy either category.

If I send my physical documentation ... - ITIN W7 Application

Itin Application Supporting Documents IRS streamlined the number of documents the agency accepts as proof of identity and foreign status to obtain an ITIN. There are 13 acceptable documents. Each document must be current and contain an expiration date. IRS will accept documents issued within 12 months of the Itin Application Supporting Documents
