On 25 May 2017, The Queensland Government introduced the Labour Hire Licensing Bill 2017 into Parliament. The bill would see labour workers protected from exploitation and restore confidence in the labour hire industry. Industrial Relations Minister Grace Grace explained that the licensing scheme introduced by the Bill is the only viable option following widespread evidence of rotting and exploitation of workers.

Labour Hire Licensing Act 2017 – integrity in the labour hire industry In September 2017, the Queensland government passed the Labour Hire Licensing Act. Comparable legislation has been passed in South Australia (commencing 1 March 2018) and is before parliament in Victoria (yet to be passed) which is similar but not identical.

The SA Bill proposes to amend the Labour Hire Licensing Act 2017 to "ensure that the law applies only to labour hire providers operating within high-risk industries where workers are vulnerable to exploitation". The aim of the amendments proposed by the SA Bill are stated as being to "narrow the scope of the scheme".
